How to Apply for Federal Aid?	Types of Financial Aid	General Eligibility
Students should visit <u>studentaid.gov</u> to fill out a valid FAFSA before each academic year. Students who are U.S. Citizens or eligible non-U.S. citizens must have a valid FAFSA on file with the university to be reviewed for eligibility. Students must submit a valid FAFSA for the appropriate academic year with our Federal School Code 002104 .	There is a plethora of resources available to assist students in funding their academic career including but not limited to: • Federal Loans • Federal Work-Study • Private Loans	You must demonstrate financial need (for some programs); be a U.S. citizen or an eligible noncitizen; have a valid Social Security number (with the exception of students from the Republic of the Marshall Islands, Federated States of Micronesia, or the Republic of Palau) Students must be properly enrolled in at least 6 credits, which is half time status. ** Students enrolled in the Advanced Education General Dentistry (AEGD) are not eligible for financial aid which includes federal or private student loans.

Cost of Attendance (COA)	Expected Family Contribution (EFC)	Financial Need
An institution's COA is an estimate of what it may cost for you to live and attend your program during the academic year. You may review the components of a COA here or visit your SURFS account to view your COA.	Despite its name, the EFC does not indicate how much a student will have to pay out of pocket to attend. It is primarily used as an indicator of financial need.	A student's financial need is determined by calculating the difference between the Cost of Attendance (COA) and the Expected Family Contribution (EFC).

 Not all students are eligible for FWS. Students should contact the financial aid counselor for their program to learn if they are eligible. Students may be offered the federal unsubsidized loan up to \$20,500 per year, depending on whether or not they have reached the aggregate limit of \$224,000 during dental school. The School of Dentistry Post Graduate Residency Program does not have a summer term. The fall term begins in July.
